Additionally, the Finance Committee reviews the 990 before it is provided to Board of Trustees.

03. Conflict of Interest Policy Compliance (Part VI, line 12c): We are a small enough organization that we generally know what the other members are doing, so we can and do call each other out if there is a conflict. In the instances where conflicts are not obvious or not publicly known, members are expected to announce the conflict prior to acting.

04. Governing documents, etc. available to public (Part VI, line 19): These are available upon request.

05. Explanation of other changes in net assets (Part XI , line 9):

There are (4) transactions within this change in net assets. (3) transactions deal with the removal of small value assets (each is \$50 to \$230)

We track these as inventory due to the large number of them that we own (over 200). Because these are inventoried, they lack depreciation and thus do not show up on the SoFE, so a General Journal Entry (GJE) is required to remove them from the books, and the GJE does not reflect on the SoFE, so Part XI line 9 is the only place to reflect this on the 990. The (3) transactions are GJE # 181, 202 & 240 and account for a decrease of \$500 in assets. The last transaction is due to an adjustment of Fixed Assets. The Depreciation Schedule was reconciled with the Fixed Asset list per GJE # 265. This adjustment results in an addition of \$5,183 to Fixed Assets.

These (4) transactions are responsible for the \$4,683 change in net assets.
